Board member Bryan Sellner introduced the following resolution and moved its adoption:

**RESOLUTION RELATED TO THE EXPULSION OF THE STUDENT IDENTIFIED IN THE ATTACHMENT AS THE "STUDENT"**

WHEREAS, the student was proposed for expulsion pursuant to the Pupil Fair Dismissal Act, Minn. Statutes 121A.40-121A.56; and

WHEREAS, the student and his parents were served the written notice of the School District's intent to initiate expulsion proceedings and such notice was accompanied by a copy of the Pupil Fair Dismissal Act. Minn. Statutes 121A.40-121A.56, as required under the Act; and

WHEREAS, the student and his parents elected to waive the scheduled hearing with the understanding that such waiver, the proposed terms of the expulsion would be submitted for action to the School Board of Independent School District No. 84

THEREFORE BE IT HEREBY RESOLVED by the School Board of Independent School District as follows:

1. The School Board hereby accepts the Waiver of Hearing executed by the student and his parents, a copy of which is attached hereto as Exhibit A and incorporated herein by reference.
2. By reviewing the record relating to the matter, the School Board hereby finds that due to the nature of the conduct engaged in by the student the terms of expulsion proposed by the School District are reasonable and appropriate.
3. The school Board of Independent District No. 84 hereby orders that the expulsion of the student be imposed immediately pursuant to the Pupil Fair Dismissal Act Minn. Statutes 121A.40-121A.56 through May 20<sup>th</sup> 20-21. Said expulsion shall be imposed in accordance with the written notice provided to the student and his parents, a copy of which is attached hereto as Exhibit B.
4. The Clerk of the School Board is directed to provide a written notice of the expulsion to the student and the parents in substantially the form as provided in attachment Exhibit C.
5. It is further ordered that pursuant to a proper request, the school District shall provide copies of the resolution. However, any release of said Resolution shall not include the exhibits or attachments hereto as to the School Board hereby finds that such materials constitute private

data on individuals pursuant to the Minnesota Government Data practices Act, Minn. Statue  
13.32
