Superintendent: Covid Update: No cases!!! School Based Mental Health Update: Working with Greater Minnesota and they are very interested in helping however it will cost \$10,000 more, but the need is great we have a lot of students on waiting lists for services. Solar Grant update, both schools were approved funding at \$60.000. Kindergarten round up completed and we had a turnout of 31 students, John is expected to have 50 enrolled. Voluntary Pre-K Application has been approved by MDE for FY 2023. Ag. Summer grant has been approved by MDE. Completed 3<sup>rd</sup> observations with non-tenured staff, wanted to be completed by testing time.
