Reports:

Board Committees: BCPH met and as you can guess we have seen an increase in influenza A infections and there does not appear to be a peak this year. Covid cases are down but then less people are reporting them. Norovirus is everywhere right now, commonly known as the stomach flu. Policy met and went over policies and dropped the COVID policy but then brought in a service animal policy because we did not have one. Riverbend met there is a retirement ahead and they need more space. There is a waiting list to get students in. Looking for new insurance. ECFE met and they have a lot of students and the last days of school are coming up for them. Summer sessions are coming up. They also have some home sessions that they can do.

Principal: Two boys on the State hockey team and they were excellent Kayden Klein and Austin Uecker. Two wrestlers also made it to state. Interviewing and touring going on, spending time on the schedule for next year.

Superintendent: **Legislative Update:** With the fourth week of the session wrapping up, it was a busy week of committee hearings. The House and Senate education policy committees have been especially busy as they try to hear their priority bills by the March 22 deadline. The Senate Education Policy Committee has one more week of bill hearings. The committee will release its omnibus policy bill the week of March 18 and pass it out of the committee later that week. The House Education Policy Committee has not given a timeline on its omnibus policy bill, but I believe it is similar to the Senate. John will work on addressing a bill that would allow us schools that have to change mascots that we get funding for the name change on a bonding bill.

Clarification on school resource officer law passes House

<u>Legislation</u> to clarify the 2023 law that led to uncertainty for school resource officers continues to advance. The House passed the bill on March 4 with no amendments and broad bi-partisan support (124-8). In the Senate, the bill had its last committee stop and is headed for a vote in the Senate soon. **MSBA/MASA Day at the capitol event March 18**: Darla and I are attending. We

have appointments with Senator Dahm and Rep. Torkelson. Presented at the March 12 Sleepy Eye City Council meeting about the potential building addition. Kindergarten round up completed there are 30+ kindergarteners. Voluntary Pre-K Application has been approved by MDE for FY 2025. Literacy night on March 12. Grandparents Day Wednesday March 27th Riverbend building lease: In order to address space needs Riverbend Ed. District is going to enter into a building lease for the next five years. We will use our lease levy to pay for this.

New Lease \$78,300.00 our portion is \$6585.03. Dashir Report: Personnel Information We are fully staffed Bruce L. will be Starting back this week helping with spring sports. Training Conducted, March training is Electrical Safety. Inspections, Monthly fire extinguisher and exit light inspections. Will be helping Tim complete a water test this month. Employee monthly audits are completed. Progress on Projects, Cafeteria roof is on hold as of now, re-caulking of ext. windows on the east side of the building are on the schedule.

Presentation: Building project survey information: Daren Sievers Project Manager, School Perceptions. These are the people that would help us with our surveys with the community partnership for the multipurpose/ recreation building. Looking at having the findings to be presented at a June/July meeting. They have a very high accuracy rate.

Discussion: School Mascot: We are going to use a two-vote method.
