<u>Board:</u> BCPH met Covid cases saw a mild decrease and there continues to be no Monkey Pox cases in Brown County, the South Central Region has the lowest rate of overdose deaths. Facilities met and storage continues to be an issue with cleaning and stage lighting. Solar power for the schools is not going on yet working on documentation. Policy met and went over the 100's series of policies. Riverbend met and staffing is hard to find, still in need of a new roof.

<u>Principal:</u> I am finishing up the first round of evaluations for non-tenured teachers. Working on getting an after school program up for 7th and 8th graders. <u>Superintendent</u>: Policy committee: We are in a process to review all policies. Committee members reviewed the 100 series policies. We will approve the updates at our November meeting. Plan to update all policies by the end of the school year. Compensatory revenue update: 2022-2023: \$247,586 2023-2024 projected revenues based on 10/1/2022 enrollment: \$378,668. Branding and Marketing update: Cory and I had a zoom meeting with Varsity Brands Impact. They will assist us finalizing our branding logo as well as developing a new logo design for our athletic teams. Lifetouch will provide us free branding banners after we finalize this process. Parent teacher conferences: Tuesday October 18th 2022. October 19th Noon dismissal for Staff development activity . Teacher observation update he is 30% done, plans to have them all done with 2nd & 3rd rounds by January or February.

Discussion Items

Meal and Mileage reimbursement: Meet and Confer had a meeting and discussed the teacher and student reimbursement. It was brought up that when they go on the class trip there is no way that \$45 a day pays for anything. When students make it to the state level for anything they are given \$7 a day and that is not feasible. Amanda sent us documents that other districts are using. So we are looking at location specific rates. We are going to use the IRS document that is located on the internet and increase the rates as such. Looking at doing the same thing for millage rates so the office will fill that out. Casey says we should make it the same for students and staff for an overnight stay. We will continue to study this but maybe increase the student rate to \$20.
