Superintendent: Covid update: County Case rate outlook; total positive cases since start of the school: 3 (all completed isolation time); 2 staff and 1 student, have some in isolation now but still attending school online. Virtual student data update; have approximately 75 students that are attending virtually but that number is decreasing as time goes on. Student free meal offer extended until the end of the school year. Virtual conferences are taking place this week and next, will report on attendance next time.
